

# Latin American Community Center



The Latin American Community Center (LACC) is Delaware's premier multi-service agency serving the state's Hispanic community. For over 50 years, the LACC has served as a vital community anchor and a beacon of hope for many Latinos, touching the lives of over 25,000 people annually and directly serving 7,000 individuals with programs supporting youth educational achievement, family self-sufficiency, workforce training, prevention and advocacy.

### **After-School and Summer Programs**

LACC's Before and After School Program is is a top-rated (Delaware Stars Level 5) program in **Wilmington's Hilltop neighborhood** providing low-income students with enrichment and academic supports to promote achievement and personal development. From June until August, LACC also runs a summer day camp for children in kindergarten through sixth grade. **LACC does not have a suitable outdoor place for the 200+ students we serve every day to play outside.** 

### **Outdoor Playground Project**

LACC's **Outdoor Playground** is an **\$695,000 investment in outdoor play infrastructure** for the primarily lowincome Hispanic youth engaged in LACC's after-school and summer programs. The project will promote exercise, fun, and healthy lifestyles among children with few options for outdoor play.

#### **Project Summary:**

LACC's Outdoor Playground is an \$695,000 outdoor play space for 200+ youth ages 5-18.

Readiness to Proceed Site control: Complete Expected completion date: Dec. 2023

LACC has raised \$100,000 through a multi-faceted capital campaign. To complete the project, LACC is seeking an ARPA investment of \$595,000.




### Who LACC Serves:

- 200+ school-aged children ages 5-18
- **90%** of children currently enrolled in our afterschool and summer programs are **Hispanic**.
- **85%** are from **low-income families** that qualify for Purchase of Care.

### Why Exercise and Outdoor Play Is Important:

Most LACC students live in dense urban neighborhoods with no access to safe spaces to play outdoors. There is a correlation between lack of physical activity and overweight and obesity. Hispanic children have the highest rates of obesity in Delaware. A sedentary lifestyle is also a risk factor for chronic diseases and more severe COVID-19 outcomes. The Centers for Disease Control (CDC) states that "neighborhoods people live in have a major impact on their health and well-being." The CDC identifies "neighborhoods and built environment" as one of five key social determinants of health and includes "creating neighborhoods and environments that promote health and safety" as a top goal.




## American Rescue Plan Act (ARPA) Eligible Use

LACC's Outdoor Playground will be built at the corner of W. 4th St. and N. Harrison St. in Census Tract 22, which is a **Qualified Census Tract** (QCT) located in the Hilltop neighborhood in Wilmington's West Side. LACC's Outdoor Playground meets the following **eligible use under Treasury's Final Rule** for ARPA funds:

• Developing neighborhood features that promote improved health and safety outcomes, such as parks, green spaces, and recreational facilities in disproportionately impacted communities.<sup>1</sup>
